**ANNEXURE A: VARIATION AGREEMENT**

**WHEREAS** the parties have entered into a Subscriber Agreement on \_\_\_\_\_ ;  
**WHEREAS** the parties now wish to add to the terms and conditions of the said agreement;  
**WHEREAS** clause 13.5 of the said agreement makes provision for the addition thereto provided that such addition is reduced to writing and signed by the parties;  
**WHEREAS** the provisions of the said agreement are applicable to this annexure as if specifically incorporated herein, save and except where expressly stated otherwise in this annexure.

**NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:**

1. Where the Subscriber subscribes to either the Vodacom or MTN HSDPA/3G packages HSDPA; 3G; EDGE; GPRS AND WLAN network coverage and availability will be provided to the Subscriber. However due to limited network coverage, the Subscriber will be responsible for verifying the availability of coverage within his/her area.
  
2. The Subscriber:
  - 3.1 is aware that HSDPA , 3G, EDGE , GPRS and WLAN network coverage may be sporadic;
  - 3.2 has verified the status of availability of coverage;
  - 3.3. understands the limitations of the services and the coverage and will not hold Autopage liable in the event of limited or no coverage.
  
4. The Subscriber:
  - 4.1 agrees that there will be 2 (two) SIM cards connected onto the Subscriber's account which will consist of 1 (one) voice Line (Either Vodacom Talk 120 or MTN Procall 120) and 1 (one) data line (Either a Vodacom 500mb or MTN Extended data 500mb);
  - 4.2 acknowledges that the aforementioned SIM cards related to this offer may only be taken over 1 (one) network at a time;
  - 4.3 agrees that he/she will receive a statement from Autopage which shall reflect billing of both the SIM cards (voice and data) thereon;
  - 4.4 acknowledges that the warranty regarding the Laptop is held by the manufacturer, Pinnacle Micro and that Pinnacle Micro will be contacted directly for any service queries or matters relating to the warranty on the following service numbers;
