ADDENDUM TO SUBSCRIBER AGREEMENT

MIGRATION APPLICATION – PRE PAID TO A FIXED TERM PACKAGE

(This addendum must have the standard subscriber agreement attached)

I, the undersigned _____ do hereby agree and acknowledge that upon completion of this addendum and acceptance hereof by AUTOPAGE Cellular (PTY) LIMITED ("AUTOPAGE"), to be bound by the provisions contained in any notice, directive or applicable tariff plan issued or derived by AUTOPAGE with respect to migration applications from a Pre Paid package to a Fixed term package. I furthermore agree to be bound by the terms and conditions as set out below: -

1. I acknowledge that this document constitutes an application by myself (the "subscriber") to migrate from my existing Pre Paid package to a fixed contract, which may be accepted or refused by Autopage in its sole discretion. I, the subscriber herewith expressly dispense with notification of acceptance of the offer by Autopage.
2. Upon acceptance and commencement of the migration, Autopage shall be entitled to charge a migration fee, as per the applicable Autopage tariff plan, which will be payable by myself ("the subscriber"). I hereby authorize Autopage to effect deductions by way of debit entry, (or entries) on my account, the details of which appear on the Subscriber Agreement.
3. I, "the subscriber" shall pay to Autopage, the charges for any value added services which I applied for and utilised in accordance with the previous Subscriber package, which may be charged by Autopage upon migration and accordingly, unless such value added services are now included in the new tariff to which I, the subscriber wish to migrate, such charges shall continue to be applicable and payable by myself.
4. Any Rand value of airtime and access days purchased by myself, "the subscriber", in accordance with the Pre Paid tariff package, or additional products, must be utilised by myself / "the Subscriber" before the migration takes place failing which such remaining airtime or access shall be forfeited. Autopage shall not be obliged to effect any compensation whatsoever for such forfeiture.
5. Autopage shall be entitled in its sole discretion to alter the mobile telephone number or any other code or number which has been allocated to the subscriber for the subscriber equipment and/or the SIM card.
6. Autopage shall be entitled in its sole discretion to suspend, cancel, vary or terminate this agreement or any part thereof, without Autopage incurring any liability whatsoever, in the event that the agreements between the network operators and Autopage be terminated, so as to have the effect to Autopage not being entitled to render the services.
7. I, "the subscriber" warrant that the information contained in this document is true and

correct, and such information forms the basis of this document. I agree that should such information turn out not to be correct in all respects, Autopage shall be entitled immediately and without prejudice to any other rights that Autopage may have to terminate this agreement and I agree to hold Autopage harmless in such an event.

- 8. No alteration, variation, or addition to the Subscriber Agreement and this addendum or clause shall be of any force or effect unless reduced to writing and signed by a Director / duly authorized employee of Autopage.

I have read and agree to:

- 1. The terms and conditions for the cellular service agreement as stated on the reverse side of the Subscriber agreement.
- 2. The above provisions and agree to be bound by them.
- 3. The applicable Autopage Cellular tariff plan which will form part of this addendum.

I also declare that in my capacity as of the entity, I am authorized and empowered to sign and enter into this addendum on behalf of the applicant.
